For RVA-IGCD (2nd reading) looks good to me. The re-write I'm good with for this time around. Charlie answered the question about an "undue financial burden" form - 3rd arrow, page 3. We should remove the 4th bullet, page 5 as RVA doesn't have a distance learning network.

RVA-IKF (2nd reading) Charlie's thinking on this one, keeping all info on graduation in one spot, makes sense to me. I can leave it as is.

RVA-IGHA combine RVA-IGHB let's combine them as we had talked about and leave the anti discrimination language in the finished combined product in order to appearse DPI.

RVA-IKE Charlie's explanation of the "E" grade and with it in a handbook, fine with me.

RVA-IKFB I've associated walking across the stage and getting a diploma as one in the same thing. I know there are situations whereby a student walks across the stage and then at some later date when it has completed some requirement is unceremoniously awarded a diploma. So, I'm cool with leaving RVA-IKFB as is.

## Hi Charlie, Hi Becky

Here are some questions. I am including copies of all policies from 1st reading plus the two from 2nd reading with questions.

If we are able to make changes, get revision to the policy committee for their ok within the week, then policy's motion was to accept policies in 2nd reading with change and review/revision by RVA. Otherwise, we have to bring IGCD & IKF back for another month.

### **RVA-IGCD**

Page 2 - more procedural "the student will" versus "you will and your." I took a stab at it. :) You did a good job, but I don't know how else the policy committee would like it to read. You can keep ironing this out.

Page 3 - after the chart, 3rd arrow, poses an undue financial burden, is there a form for this? I do not know. This is a determination made by the DPI and an occurrence I have yet to encounter, but I suspect their must be either a form or an appeals process for families to follow in the event this were to happen.

Page 5 - on the form, RVA-IGCD-E, 3rd bullet, it refers to distance learning and that is not mentioned any other place in the policy. Should that be part of this form? Not in my opinion. The RVA doesn't have a distance learning network. (MASH belongs to NWECS yet, I believe, so this would apply to them in the non-RVA sector policy, but it should be removed from the RVA policy.) It was left over when this policy was originally drafted by Jennifer, I believe.

#### **RVA-IKF**

What are the actual requirements? Keep it to requirements versus options or what is allowed. Do you need to state the phy ed requirements since you have a policy on that? Some of these bullets are covered in other policies like physical education. I like redundancy in policies such as this as they have practical "one stop" applications for students, parents, counselors, and principals as opposed to parents having to dredge through multiple different policies to see what is allowed and required for graduation. I would prefer to leave it as is.

RVA-IGHA & RVA-IGHB - combine these two policies, change title to Physical Education and state equivalent courses first and then exemptions. I didn't make these changes yet in case you do not agree. Last paragraph on IGHA, what is gifts, bequests, scholarship, etc mentioned. Do we even need the discrimination statement in this policy? You can certainly combine the two policies. That last parapgraph in IGHA is the district's / RVA's general "non-discrimination statement" which we tend to include in any policy which denotes either including or excluding students of federally protected classes or other potentially discriminitatory reasons. It is not necessary to keep in this policy, but agencies who audit our sector RVA policies, (such as the DPI every 5 years) appreciate seeing this language included.

#### **RVA-IKE**

Page 3 - explaining "E" grade. Can it be given in place of a "C?" Give a better explanation of when this would be used.

Per our student handbook, this is an example: "If an individual student's course content and/or assessments is modified, (not accommodated), to exclude more than 25%, they will be awarded a "P" or "E" grade as determined by the course instructor and RVA administration." This a rare occurrence, but when applied is almost exclusively for full-inclusion intellectually disabled students.

#### **RVA-IKFB**

4th bullet - do you need this if you are saying it in the 1st bullet? First bullet says you get to walk across the stage, bullet 4 says you actually get a diploma. To me they are not the same.

### RVA-IL

Page 2, are these tests current? Yes. They are good.

Hopefully I have everything. Thanks for your help! **Thank you for everything, Becky!**
