Legislative Update: DPI 25-27 Budget Proposal

Asking for \$4 billion in new spending

- Per pupil increase to revenue limits (\$325)
 - o \$425 in 2026
 - o \$437.75 in 2027
- Increase special ed reimbursement rate to 90% by 2027. Current rate is 31.5%
- \$311 million for school nutrition
- \$304 million for youth mental health
- \$60 million to help districts recruit & retain teachers
