Organizational Business

1. Administration of Board Oath

[Board Clerk, Chyerl Wibben, hands out oaths, one at a time] "At this time, I would like each of the newly elected board members to take the Oath of Office. Board members, when giving the oath, please stand (one at a time), raise your right hand and recite the Board of Education Oath of Office out loud as stated on this sheet."

" Name (OraLee Dittrich, Dave Fleegel and DeDe Strama), please stand and recite your Oath." (OraLee, Dave and DeDe, recite the Oath.)

"Thank you (OraLee, Dave and DeDe). Now, with the authority vested in me by State Statute 120.17, I accept your Oaths of Office and extend to each of you my congratulations and best wishes during your time on the Board."

2. Organization Meeting
 - a. Election of President, Vice President, Clerk and Treasurer

The Board Organizational portion of the meeting will take place at this time, including the election of officers. By law, new board members must take the Oath of Office by the fourth Monday in April (done on April 16). Also, by law, the new board must reorganize on or within 30 days of the fourth Monday in April.

[Note: Current Acting Board President runs this portion of the meeting.]

Election of President

(Nominations do not need to be seconded.) The Administrator will count the confidential ballots and report the results to the board. He will then give the ballots to the clerk for verification.

[Note: New Board President runs this portion of the meeting.]

Election of Remaining Board Officers (Vice President, Clerk and Treasurer).

3. Designation of Official Depositories

- a. The Board maintains funds in several financial institutions. These institutions need to be designated as depositories each year. It is recommended that the Board consider designating the following as Official Public Depositories for 2018-19:

1. Fidelity National Bank, Medford, WI
2. Nicolet National Bank, Medford, WI
3. Local Government Investment Pool
4. Forward Financial Bank, Colby, WI and Medford, WI

4. Designation of Official Newspaper

The Board needs to designate an official newspaper. We receive much coverage from the Star News, therefore, you may want to designate the Star News as the official newspaper.

5. Appointment of WASB Correspondent

One member of the Board plus the District Administrator receives all WASB correspondence. Important correspondence should be brought to the attention of the Board by the correspondent. This person may be designated at this time.

6. Appointment of WASB Delegate and Alternate Delegate

Appointments for WASB Delegate and Alternate Delegate to the WASB Convention need to be made.

7. Appointment of CESA Representative and Alternate Representative

A CESA representative and alternate representative needs to be appointed for the CESA Annual Meeting in August.
