Students and parents attending the FAFSA Completion Help Events and College Goal Wisconsin will need the following items to complete the 2024-25 FAFSA:

- 2022 Federal Tax Return and W2s
- 2022 Untaxed Income Records, such as child support or veteran's non-education benefits
- Information on savings, investments, business assets and farm assets (if applicable)
- Driver's License (if you have one)
- Cell phone (if you have one)
- Social Security Number
- Alien Registration Card or Permanent Resident Card (if you are not a U.S. citizen)
- Date of birth for parents
- Month and year of parents' marriage, divorce, or separation

It is strongly recommended that students and parents create an FSA ID before filing the FAFSA. Create an Account at:

studentaid.gov/fsa-id/create-account/launch

The information provided during the creation of an FSA ID needs to be matched with the Social Security Administration, which can take up to several days.

What you'll need when creating an FSA ID:

- Social Security Number
- Mobile phone number
- Personal email address (do not use a school email, since a school email may become inactive after graduation)

The new FSA ID process for those without SSNs will launch on the same day as the 2024-25 FAFSA (December 31, 2023). When the updated process launches, it will require everyone (if you currently have an FSA ID or are just creating one) to have an email address. Parents who don't have a Social Security number (SSN) will be able to create a StudentAid.gov account to access and complete their portion of your FAFSA form.
